ORDINANCE NO. 24.

AN ORDINANCE to Provide for the Sale of East Market Square, and to Convey the Funds Received Therefor Into the City Treasury.

BE IT ORDAINED by the Mayor and City Council of the City of Fort Calhoun, Nebraska:

Section 1. That it shall be lawful for the said City Council to submit to the legal voters of said city at the next general city election, to-wit: the first Tuesday of April, A.D. 1894, the question: Shall the City Council sell East Market Square for not less than Three Hundred and Fifty Dollars (\$350.00)?

Sec. 2. Those wishing to vote in favor of said proposition shall write after the question, "Yes". Those wishing to vote against the question shall write after the question, "No".

Sec. 3. If, after the regular canvass of all the votes cast at said City election, there shall have been found a majority in favor of said proposition, then the same shall be by the canvassing board, declared to be carried. If, after the regular canvass of all the votes cast at the said city election, there shall have been found a majority against said proposition, then the same shall be by the canvassing board, declared to be lost.

Sec. 4. If the proposition shall be by the canvassing board declared carried, then it shall be the duty of the Mayor to cause notices to be posted in five of the public places in the City of Fort Calhoun, giving ten (10) days' notice of the sale of East Market Square, giving time and place of sale, and then sell to the highest bidder at not less than Three Hundred and Fifty Dollars (\$350.00).

Sec. 5. If said proposition carries and sale is made, the Mayor is hereby authorized to make out and deliver to the purchaser a good and sufficient deed of warranty, under seal of said city and countersigned by the City Clerk and acknowledged in due form.

Sec. 6. It shall be the duty of the Clerk to convey to the treasury of said city the money received therefor, for the benefit and to the credit of the General Fund of said city.

Sec. 7. This ordinance shall take effect and be in force from and after its publication, as required by law.

ORDINANCE NO. 25.

AN ORDINANCE Adopting the Survey and Plat Made by J.C.W. Kline, and Fixing the Boundary Lines of Streets and Alleys to Conform Therewith.

BE IT ORDAINED by the Mayor and Council of the City of Fort Calhoun, Washington County, Nebraska:

Section 1. That all streets in said city, except 14th street and Clay street, shall be the uniform width of sixty-six (66) feet, and the curb line twenty-three feet from the center line of said streets on either side thereof.

Sec. 2. AND BE IT FURTHER ORDAINED, that 14th street shall be of the uniform width of ninety feet, within the boundaries of the City of Fort Calhoun, and of the width of eighty (80) feet within the boundaries of Fort Calhoun Company's Addition to the City of Fort Calhoun, and the curb line shall be thirty-three (33) feet from the center line of either side thereof, through the City of Fort Calhoun and twenty-eight (28) feet through the Addition aforesaid.

Sec. 3. AND BE IT FURTHER ORDAINED that Clay street shall be and remain the full width of one hundred (100) feet, and the curb line shall be thirty-four (34) feet from the center line of the street on either side thereof.

Sec. 4. AND BE IT FURTHER ORDAINED that the alleys in said city shall be and are hereby established as shown by the survey on plat of J.C.W. Kline, to be filed in the County Clerk's office.

Sec. 5. AND BE IT FURTHER ORDAINED that the plat and survey, as made and done by J.C.W. Kline, be and the same is hereby made, established and confirmed as the official survey and plat of the City of Fort Calhoun, Nebraska, made in the year 1894, and as such shall be received in evidence in all courts of equity and justice in this city.

Sec. 6. AND BE IT FURTHER ORDAINED, that the Mayor of said City shall file said plat with the County Clerk of Washington County, Nebraska, as such official and approved plat of the survey of said city as aforesaid, as per the statutes in such cases made and provided.

Sec. 7. All ordinances or parts of ordinances conflicting with this ordinance, or any part thereof, shall be and the same is hereby repealed.

Sec. 8. This ordinance shall take effect and be in force from and after its publication, according to law.

ORDINANCE NO. 26.

AN ORDINANCE to Provide for the Sale of East Market Square, and to Convey the Funds Received Therefor into the City Treasury.

BE IT ORDAINED by the Mayor and City Council of the City of Fort Calhoun, Nebraska:

Section 1. That it shall be lawful for the said City Council to submit to the legal voters of said City at the next general city election, to-wit: the first Tuesday in April, A.D. 1898, the question, Shall the City Council sell East Market Square for not less than Three Hundred Dollars (\$300.00)?

Sec. 2. Those wishing to vote in favor of said proposition shall write after the question, "Yes". Those wishing to vote against the proposition shall write after the question, "No".

Sec. 3. If, after the regular canvass of all the votes cast at said city election, there shall have been found a majority in favor of said proposition, then the same shall be by the canvassing board, declared to be carried. If, after the regular canvass of all the votes cast at the said city election, there shall have been found a majority against said proposition, then the same shall be by the canvassing board, declared to be lost.

Sec. 4. If the proposition shall be by the canvassing board declared carried, then it shall be the duty off the Mayor to cause notices to be posted in three of the public places in the City of Fort Calhoun, giving ten days' notice of the sale of East Market Square, giving time and place of sale, and then sell to the highest bidder at not less than Three Hundred Dollars (\$300.00).

Sec. 5. If said proposition carries and sale is made, then the Mayor is hereby authorized to make out and deliver to the purchaser a good and sufficient deed of warranty, under seal of said city and countersigned by the City Clerk, and acknowledged in due form.

Sec. 6. It shall be the duty of the City Clerk to convey to the Treasurer of said city, the money received therefor, for the benefit and to the credit of the General Fund of said City.

Sec. 7. This ordinance shall take effect and be in force from and after its publication, as required by law.

ORDINANCE NO. 27.

AN ORDINANCE Granting Certain Rights and Privileges to the Nebraska Telephone Company, its Successors and Assigns, Regulating Erection of Poles and Wires, and Protecting the Same in the City of Fort Calhoun, Nebraska.

BE IT ORDAINED by the Mayor and City Council of the City of Fort Calhoun, Nebraska:

Section 1. That the Nebraska Telephone Company, its successors and assigns, be and are hereby granted right-of-way for the erection and maintenance of poles and wires, and all the appurtenances thereto, for the purpose of transacting a general telephone and telegraph business through, upon and over the streets, alleys and public grounds of the City of Fort Calhoun, Nebraska. -- PROVIDED, that said company shall, at all times when requested by the proper authorities, permit their poles and fixtures to be used for the purpose of placing and maintaining thereon free of charge, any wires which may be necessary for the use of the police or fire departments of the city of Fort Calhoun, Nebraska, and further provided, that such poles and wires shall be erected so as not to interfere with ordinary travel through such streets and alleys.

Sec. 2. Whenever it shall be necessary for any person to move along or across any of said streets or alleys, any vehicle or structure of such height or size as to interfere with any poles or wires so erected, the company using and operating such poles and wires shall, upon receiving twentyfour hours notice, served in writing upon their agent or manager, Fort Calhoun, Nebraska, and upon receiving payment of the actual cost thereof, temporarily remove such poles and wires from such place as must necessarily be crossed by such vehicle or structure, and provided that this section shall not be construed to apply to circus or other parades upon the public streets or alleys.

Sec. 3. Any person who shall interfere with, cut, injure, remove, break or destroy any of the poles, wires, fixtures, instruments or other property of the said telephone company or its successors, shall be deemed guilty of a misdemeanor, and on conviction thereof shall be fined in any sum not less than ten dollars nor more than one hundred dollars, and any person who shall paste, tack or fasten on the poles or fixtures of said company, any sign poster, advertisement or

banner, shall be fined in any sum not less than five dollars nor more than fifty dollars.

Sec. 4. This ordinance shall take effect and be in force from and after its passage, approval and publication, according to law.

ORDINANCE NO. 35.

AN ORDINANCE Granting the Right-of-Way to the Blair Telephone Company Through the Streets and Alleys of the City of Fort Calhoun, Nebraska, and Declaring Certain Acts Misdemeanors, and Providing for the Punishment of the Same.

BE IT ORDAINED by the Mayor and Council of the City of Fort Calhoun, Nebraska:

Section 1. That the right-of-way is hereby granted to the Blair Telephone Company through the streets, alleys and public grounds of the City of Fort Calhoun, Nebraska, for the purpose of erecting poles, wires, and all other necessary appurtenances for the purpose of maintaining a telephone system within said city. -- PROVIDED, such poles, wires and appurtenances shall be erected so as not to interfere with the ordinary travel through such streets, alleys and public grounds. PROVIDED, further, that whenever it shall be necessary for any person to move along or across any such street or alley any vehicle or structure of such height or size as to interfere with any such poles, or wires so erected, the said company using or operating such poles, wires and appurtenances, shall, upon receiving twelve hours' notice thereof, temporarily remove such poles or wires from such place as must be crossed by such vehicle or structure; and, PROVIDED, further, that said company shall at all times when requested by the city authorities, permit such poles to be used for the purpose of placing and maintaining thereon any wire or other appliances which may be necessary for the use of the police or fire department of said city.

Sec. 2. Any person who shall interfere with, cut, injure, remove, break or destroy any of the poles, wire, fixtures, instruments, appliances or other property of said telephone company, within the corporate limits of said city, shall be deemed guilty of a misdemeanor, and upon conviction thereof, shall be fined in any sum not exceeding one hundred dollars, and pay the costs of the prosecution.

Sec. #. This ordinance shall take effect and be in force from and after its passage, approval and publication, as required by law.

ORDINANCE NO. 42.

AN ORDINANCE Submitting to the Legal Voters of the City of Fort Calhoun, Nebraska, the Proposition of Voting at the Regular City Election, to be Held by Said City on Tuesday, April 2d, 1912, For or Against the Issuance and Sale of the Bonds of Said City, to the Amount of Eleven Thousand Dollars (\$11,000.00), Drawing Interest at the Rate of Five Per Cent (5%) per Annum, Payable Annually, Due in Twenty Years from Date of Issue and Optional after Five Years, and to Authorize the Levy of the Necessary Tax to Pay Principal and Interest Thereon When Due; for the Purpose of the Construction, Erection, and Payment of a Municipal Water Works System, Complete, Including Pumping Station, Apparatus, Wells, Reservoir, Hydrants and Mains.

BE IT ORDAINED by the Mayor and Council of the City of Fort Calhoun, Nebraska:

Section 1. That there be submitted to the legal voters of the City of Fort Calhoun, Nebraska, at the regular city election to be held with and for said city on Tuesday, the 2d day of April, 1912, the proposition of voting for or against the issue and sale of the bonds of said city to the amount of Eleven Thousand Dollars (\$11,000.00) to become due in twenty years from the date of issue, but payable any time after five years, drawing interest at Five Per Cent (5%) per annum, payable annually, the same to be called "Water Bonds" and issued for the purpose of erecting, constructing, locating and maintaining a municipal waterworks system complete, including water mains, hydrants, reservoirs, pumping station apparatus and wells, also to levy and collect as required by law a general tax to pay interest and principal as the same matures.

Section 2. That a notice of the time, place and purpose of said election shall be given by publication by publishing said notice in The Tribune, a legal weekly newspaper of general circulation in said City of Fort Calhoun, Nebraska, for at least two weeks prior to the date of said election.

Section 3. That the aforesaid proposition be placed on the Official Ballot of said regular City Election held in and for said city, on Tuesday, April 2d, 1912, and to be voted on at said election, and said votes be canvassed and returns made as required by law and ordinances for the canvass and returns of said Election.

Section 4. This ordinance shall take effect and be in force from and after its passage, publication and approval as required by law.

ORDINANCE NO. 48.

AN ORDINANCE establishing a Lighting System in the City of Fort Calhoun, Nebraska, calling a special election in said city for Tuesday, the 17th day of February, 1914, for the purpose of submitting to the electors of said city at said election the question and proposition of issuing "Lighting Bonds" in the sum of Seven Thousand Dollars (\$7,000.00), for the purpose of establishing and maintaining a lighting system in said city and authorizing and directing the giving of notice of such election, and providing for the submission of such question and proposition at such election.

WHEREAS, it will be for the benefit of the City of Fort Calhoun, Nebraska, and the inhabitants thereof, that a lighting system be established and maintained in said City, and

WHEREAS, such electric lighting plant cannot be installed by the five mill levy, as provided for under section 8704 Cobbey's annotated statutes for 1911, and

WHEREAS, it is the desire and purpose of the Mayor and City Council to establish such lighting system and to submit the proposition of issuing bonds for the establishment of said system to the electors of said City at an election to be held for that purpose, Now Therefore

BE IT ORDAINED by the Mayor and City Council of the City of Fort Calhoun, Nebraska:

Section 1. That a lighting system be and hereby is established in the City of Fort Calhoun, Nebraska.

Section 2. That a special election in the City of Fort Calhoun in Washington County, Nebraska, be and is hereby called and directed and required to be held on Tuesday, the 17th day of February, 1914, at regular polling places in said City of Fort Calhoun for the purpose of submitting to the qualified voters of said City of Fort Calhoun at such special election the question and proposition of issuing lighting bonds in the sum of Seven Thousand Dollars (\$7,000.00) as follows:

QUESTION AND PROPOSITION OF ISSUING BONDS.

"Shall bonds of the City of Fort Calhoun in the sum of Seven Thousand Dollars (\$7,000.00) be issued as may be required for the purpose of raising a sum sufficient to establish a lighting system for said City, said bonds to become due in twenty years from the date of their issue, payable at any time after five years from their date, drawing interest at 6% payable annually with interest coupons attached, said bonds to be called "Lighting Bonds" and not to be sold for less than par?"

Section 3. That the Mayor and Clerk of the City Council of the City of Fort Calhoun for and on behalf of said City, are hereby authorized and directed to give notice of such election to the electors of said City, setting forth the time when and the place where such election will be held, and a copy of the question and proposition to be voted upon at said election and cause said notice to be published by posting in five or more public places in said City at least 20 days prior to the date of said election. The said election shall be held between the hours of nine o'clock A.M. and seven o'clock P.M. on Tuesday the 17th day of February, 1914, and the said notices of election printed and posted as above required, shall so set forth and provide.

Section 4. That said question and proposition of issuing lighting bonds shall be submitted to said electors in the form of an official ballot which shall be prepared by the City Clerk. Under the question and proposition on said ballots shall be printed the word "Yes" and the word "No". All ballots of said qualified voters cast at said election with an "X" following the word "Yes" shall be counted and considered in favor of issuing the bonds mentioned in said question and proposition, and all ballots of said qualified voters cast at said election with an "X" following the word "No" shall be counted and considered against the issuing of bonds mentioned in said question and proposition.

Section 5. That this Ordinance shall take effect and be in force from and after its passage and publication.

ORDINANCE NO. 51.

AN ORDINANCE turning over to the "Fort Calhoun Cemetary Association" of Fort Calhoun, Nebraska, all property, moneys and funds of the Fort Calhoun Cemetary of Fort Calhoun, Nebraska, and directing the payment of the sum of \$1,395.80 now in the cemetary fund of said City of Fort Calhoun, to the Treasurer of said Fort Calhoun Cemetary Association, and repealing all ordinances and parts of ordinances in conflict herewith.

WHEREAS, the City of Fort Calhoun, Nebraska, has heretofore owned and had control of the Fort Calhoun Cemetary of Fort Calhoun, Nebraska; and

WHEREAS, the resident lot owners of said cemetary have heretofore made and by legal and proper proceedings incorporated a Cemetary Association in accordance with and under and by vittue of the laws of the State of Nebraska relating thereto, which said Corporation is known as the Fort Calhoun Cemetary Association of Fort Calhoun, Nebraska, and now have its Trustees and Officers elected as provided by law, and

WHEREAS, Section 127, Article IV, Chapter 50, Revised Statutes of Nebraska for 1913, requires that the property, moneys, funds and other property of said Cemetary be turned over to said Association, THEREFORE

BE IT ORDAINED by the Mayor and Council of the City of Fort Calhoun, Nebraska:

Section 1. That the Fort Calhoun Cemetary and all property, moneys and funds belonging thereto and all other property belonging to said cemetary, be, and the same hereby is ordered turned over to the said Fort Calhoun Cemetary Association, and that the Mayor and City Clerk be and they hereby are instructed and directed to draw a warrant for the sum of \$1,395.80 on the Cemetary Fund of said city, payable to the Treasurer of said Cemetary Association, being all the moneys in said fund, and turn the same and all other property of said cemetary over to said Cemetary Association.

Section 2. That all ordinances and parts of ordinances of said city in conflict herewith, be and the same hereby are, repealed.

Section 3. This ordinance will take effect and be in force from and after its passage, approval and publication as required by law.

ORDINANCE NO. 53.

AN ORDINANCE conveying to certain persons, all the right, title and interest of the City of Fort Calhoun, Nebraska, in and to all that part of Court Street and of Jefferson Street, lying and being east of the east line of Seventh Street, lying and being in the City of Fort Calhoun, Nebraska, all that part of Seventh Street and of Eighth Street, lying and being south of the south line of Jefferson Street, said Jefferson Street being in the City of Fort Calhoun, Nebraska; all that part of Third Street, lying and being south of the center line of Adams Street, said part of Adams Street having been formerly in the City of Fort Calhoun, Nebraska, all that Part of Washington Street, lying and being between the west line of Eighth Street and the east line of Seventh Street, said Seventh and Eighth Streets formerly being streets in the City of Fort Calhoun, Nebraska, and all of the alley in Block No. 102, said Block 102 having been formerly in the City of Fort Calhoun, Nebraska, and authorizing and directing the City Mayor and City Clerk, in the name of said City, to execute to said persons a deed of conveyance of said premises in the name of said City.

BE IT ORDAINED by the Mayor and Council of the City of Fort Calhoun, Nebraska:

Section 1. That for and in consideration of the sum of \$1.00, to be paid to the City of Fort Calhoun, Nebraska, by the persons hereinafter named, that the said City of Fort Calhoun, Nebraska, does hereby grant, bargain, sell, convey, and confirm unto Catharine C. Beales, Sadie C. Frahm, Parke G. Beales, J. Howard Beales, all those parts and parcels of land heretofore and now known as Court Street and Jefferson Street, both lying and being east of the east line of Seventh Street, said Seventh Street being in the City of Fort Calhoun, Nebraska, all those parts and parcels of land heretofore and now known as Seventh Street and Eighth Street, lying and being south of the south line of Jefferson Street, said Jefferson Street being in the City of Fort Calhoun, Nebraska, and all that part and parcel of land heretofore and now known as Third Street, lying and being south of the center line of Adams Street, said Adams Street was originally in the City of Fort Calhoun, Nebraska, all that part and parcel of land heretofore and now known as Washington Street, lying and being between the west line of Eighth Street and the east line of Seventh Street, said Seventh and Eighth Streets having been formerly in the City of Fort Calhoun, Nebraska, and all that part and parcel of land heretofore and now known as the alley in Block Number One Hundred and Two (102), said Block No. 102 having been formerly in the City of Fort Calhoun, Nebraska, and that upon payment of the sum hereinbefore mentioned by said persons to the Treasurer of the City of Fort Calhoun, Nebraska, and presentation of said Treasurer's receipt therefore to the Clerk of

said city, that the Mayor and Clerk of said City of Fort Calhoun, Nebraska, be and hereby are authorized and directed to make, execute, acknowledge and deliver, for and on behalf of the said City of Fort Calhoun, Nebraska, a deed of conveyance of said premises.

Section 2. This ordinance to take effect and be in force from and after its passage, approval and publication, as required by law.

ORDINANCE NO. 54.

AN ORDINANCE authorizing the Mayor and City Clerk of the City of Fort Calhoun, Washington County, Nebraska, to issue SEVEN THOUSAND DOLLARS (\$7,000.00) in Bonds of said City, numbered from One (1) to Fourteen (14) inclusive, each of said Bonds being in the sum of FIVE HUNDRED DOLLARS (\$500.00), bearing six per cent (6%) interest, for the purpose of raising a sum sufficient to establish and construct an Electric Lighting System for said City of Fort Calhoun; authorizing the Mayor and City Clerk of said City to sign and execute said bonds; authorizing the Clerk of said City to attach the Seal of said City to

said bonds; requiring said City Clerk to present said Bonds at the Office of the Auditor of the State of Nebraska for registration, and to file with said Auditor a certified copy of all acts and doing of the City Council of said City preliminary to the issuance of said Bonds.

WHEREAS, the Mayor and City Council of the City of Fort Calhoun, Nebraska did on the 22d day of January, 1914, pass an ordinance establishing an Electric Lighting System for the City of Fort Calhoun, Nebraska, and submitting to the electors of said City at a special election called for said purpose on Tuesday the 17th day of February, 1914, the proposition of issuing the bonds of said City in the amount of \$7,000.00 for the purpose of raising the necessary money to construct and establish such electric lighting system for said City and such ordinance and notice of such special election were published for the time and in the manner provided by law, and,

WHEREAS, such election was duly held on said 17th day of February, 1914, in the manner provided by law at which election 84 votes were cast, of which 56 votes were cast in favor of such proposition and 28 votes were cast against such proposition; and

WHEREAS, such proposition having received the necessary majority in favor thereof and all other legal requirements preliminary to the issuance of said bonds have been performed and fulfilled, now therefore

BE IT ORDAINED by the Mayor and Council of the City of Fort Calhoun, Washington County, Nebraska, as follows, to-wit:

Section 1.
