AN ORDINANCE OF THE CITY OF FORT CALHOUN, WASHINGTON COUNTY, NEBRASKA, TO ESTABLISH FEES FOR CITY SERVICES; REPEALING ALL ORDINANCES IN CONFLICT; TO PROVIDE FOR PUBLICATION IN PAMPHLET FORM; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF FORT CALHOUN, **NEBRASKA:**

BUILDING PERMIT FEES

- ** All building permits for new construction or remodeling/addition projects valued at \$10,000.00 to \$50,000.00 or greater, are required to place a refundable deposit down in addition to the required permit fees.
- ** Deposits are held by the City of Fort Calhoun and refunded only when all the following conditions are met:
 - ✓ Contractor/owner has called for all required inspections 402-598-3915
 - ✓ Contractor/owner has used only subcontractors who have complied with the licensing requirements of the City of Fort Calhoun
 - ✓ Subcontractors have taken out and paid for all permits
 - ✓ The owners have not occupied the area covered by the permit prior to a final, and passed inspection unless the City of Fort Calhoun Inspector have granted written authorization
