New Business

Winter Care of New Trees

- Notice or letter needs to go to businesses/snow removal personnel to make them aware that these small trees can be damaged or killed by improper snow removal
- Small trees can be damaged/killed because of snow piled up around the trunk over the winter
- One tree in particular had bark damage and may not recover
- Bricks and mulch/soil was dislodged around some trees last winter resulting in needed repairs
- Note: Snow was not piled in heaps on the sidewalk before the trees were planted
- Purchase (snow) markers for trees/mulch areas
- Schedule fall fertilizing from Omaha Tree

Hot Dogs at Halloween

- Give out hot dogs and hot cocoa in the park at Halloween
- Invite the Presbyterian Church to join the Trunk-or-Treat event in the park
