## JANUARY 23, 2019 CC MINUTES

A regular meeting of the City Council of the City of Fort Calhoun, Nebraska, was held in open and public session at 7:01 p.m., on Wednesday, January 23, 2019 at the Fort Calhoun Council Chambers, in Fort Calhoun, Nebraska.

Notice of the meeting was given in advance thereof by publication, said form of notice being a designated method for giving notice, an affidavit of publication being attached to these minutes.

Notice of this meeting was also given to the Mayor and all Council Members. Availability of the agenda was communicated in the notice and in the notice to the Mayor and Council Members. All proceedings hereafter shown were taken while the meeting was open to the attendance of the public.

Mayor Robinson publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated the location of such copy in the room where the meeting was being held.

Mayor Robinson stated persons wishing to address the Governing Body on an agenda item shall wait to be identified by the Presiding Officer; then, after stating their name and address for the record, may proceed to speak. No person, other than the Council and the person having the floor will be permitted to enter any discussion without the permission of the Presiding Officer. Remarks shall be limited to five minutes unless extended or limited and repetitive or cumulative remarks may be limited or excluded by the Presiding Officer.

Please note that the meeting minutes are not approved until the next regular City Council meeting.

On roll call, the following Council Members answered present: Nick Schuler, Lori Lammers, and Terry Fitzgerald. Member Bob Prieksat was absent.

With a quorum present, Mayor Robinson presided, and the Clerk recorded the proceedings.

Member Fitzgerald made a motion seconded by member Lammers to approve the consent agenda presented. With members Fitzgerald, Schuler, and Lammers voting "Aye", motion carried.

With members Lammers, Fitzgerald, and Schuler voting "Aye", motion carried.

The Mayor discussed Ordinance 660-Sex Offender Residency Restrictions. The city is in compliance per state statute. The Mayor and Sheriff Robinson explained how to sign up online for updates on the sex offender registry.

Member Prieksat arrived at 7:15 p.m.

Discussion and approval of the Interlocal Agreement between the City and County was tabled for next month.

Council discussed the south portion of Tax Lot 27. Member Schuler made a motion seconded by member Fitzgerald to approve to have the land put out to bid for farm lease (about 36 acres). With members Lammers, Prieksat, Fitzgerald, and Schuler voting "Aye", motion carried.

Member Prieksat made a motion seconded by member Lammers to appoint Sara Ruthven to the Park Board Committee. With members Schuler, Lammers, Prieksat, and Fitzgerald voting "Aye", motion carried.

Member Fitzgerald made a motion seconded by member Lammers to approve FCYSO Wrestling request for \$300 in Keno funds to support the athletic program provided to youths: age Kindergarten through 6th Grade. With members Lammers, Prieksat, and Fitzgerald voting "Aye", and member Schuler abstaining, motion carried.
